The bids shall be opened online at the office of the Regional Engineer, Kerala State Housing Board in the presence of the Bidders / their authorized representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non- working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.
